RULES & REGULATIONS

This document informs you of the various Rules and Regulations of Talent Plus Classes. Please read this carefully and sign at the end for acceptance.

1. Fee once paid will not be refunded or adjusted at any stage, under any circumstance.
2. In case of installment facility fees must be paid on due date. After this date, a fine of Rs. 50/- per day shall be charged as late fee till five days after due date. Thereafter students name shall be struck from the rolls. In case of re-admission the student shall have to pay the arrears of fee and fines along with the re-admission fee.
3. Payment of fee is not considered valid without a proper receipt obtained from the office of Talent Plus Classes.
4. Students enrolled at Talent Plus Classes have to maintain proper decorum in the institute premises at all times. Indiscipline of any form or misbehavior with staff could lead to suspension / rustication.
5. Students who frequently come late to the institute, may not be allowed in the institute premises.
6. If a student is absent from class for more than three days in a row he/she is required to intimate the Counselor. In case of absenteeism for long periods without prior intimation, the admission of student may be deemed cancelled without any notice and without any refund of fee.
7. Any change of address or any of the contact number should be notified to the front desk without delay.
8. Student must be in possession of Talent Plus Classes Identity Card while coming for classes and must produce the same for scrutiny by the Talent Plus Classes staff, before entry. Identity cards lost or misplaced will be replaced with a duplicate Identity Card on depositing a passport size photograph and Rs. 100/-.
9. If any cheque is dishonored for any reason, appropriate action may be initiated as per Negotiable Instrument Act. An administrative charge of Rs. 250/- would be levied for every dishonored cheque and the fee in lieu of the dishonored cheque will only have to be submitted vide a Bank Demand Draft/Cash.
10. In case of any increase in the Service Tax or Education Cess (from the existing rate of 12% Service tax plus 3% education cess thereon) by the Government of India, such increase in tax shall be borne by the student from the date of notification by the Government of India.
11. The student is responsible to see for himself / herself whether he / she is eligible for a certain examination / course or not.
12. The student has to provide the photocopy of his/her hall tickets clearly stating their roll numbers and photograph of their respective exam without fail to avail the continued services.
13. Students enrolled with Talent Plus Classes have to submit a photocopy of their mark-sheet of last examination attempted, failing which the student would not receive their Talent Plus Classes Test Series or any other study package etc.
14. Talent Plus Classes reserves the right to use the photographs and/ or testimonial letter of the student in any promotional / publicity material of the institute.
15. Talent Plus Classes reserves the right to change or alter the classroom program, fee or rules and regulations without any prior notice to anybody. The management's decision shall be final and binding on the student and parents.
